MAXI GLO is a light duty cleaner and degreaser for use on floors, walls, tile, terrazzo, concrete, woodwork, enamel, porcelain, windows, and metal surfaces. Use full strength for tough cleaning jobs or dilute as directed for general purpose cleaning. Removes grease, grime, oil, food stains, dirt, lipstick, black heel marks, carbon, soot and soap scum. Biodegradable in hard or soft water.

DIRECTIONS FOR USE:

COMPOSITION, TERRAZZO, TILE AND MARBLE FLOORS: Add 2 oz. to each gallon of warm water. Mop floor with solution, remove with squeegee or damp mop. For optimum floor coating application, rinse with clear water. For regular floor maintenance, no rinsing is required. **WOOD and CONCRETE FLOORS:** Add 1 cup to each gallon of warm water. Scrub surface, rinse with clear water. **WALLS, WOODWORK, PORCELAIN, ENAMEL, AND METAL SURFACES:** Add 4 oz. to each gallon of water. **WINDOWS:** Add 1 oz. to each 2 gallons of water. Apply with soft brush, remove with squeegee.

MODO DE EMPLEO:

PARA PISOS DE COMPOSICIÓN, TERRAZO, MOSAICO Y MÁRMOL: Agregue 2 onzas por cada galón de agua caliente. Trapee el piso y remueva con un limpiador o trapeador. Para una aplicación óptima, enjuague con agua limpia. Para mantenimiento regular, no se requiere enjuagar. **PISOS DE MADERA Y CONCRETO:** Agregue una taza por cada galón de agua. Talle la superficie. Enjuague con agua limpia. **PEREDES, MADERA, PORCELANA, ESMALTE Y SUPERFICIES METÁLICA:** Agregue 4 onzas por cada galón de agua. **VENTANAS:** Agregue 1 onza por cada galón de agua. Aplique con un cepillo, remueva con una esponja.
